



CEDIA Expo 2022 Exhibitor Registration Giveaway

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. ELIGIBILITY; METHOD TO ENTER; SUBMISSION GUIDELINES.

The Campaign is only open to legal residents of the continental U.S. and Canada, who are in the age of majority for their region at the time of participation, and is void where prohibited by law. Employees of CEDIA Expo, Emerald, and advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members are not eligible to participate in the Campaign. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of CEDIA Expo. Exhibitors in each booth category (100-600 sq.ft; 601-1,200 sq.ft; 1,201+ sq.ft) who register the most attendees with their codes will be eligible to win free exhibit space to use towards their CEDIA Expo 2023 booth.

4. DESCRIPTION AND VALUE OF THE PRIZE; ODDS OF WINNING.

The Winner(s) of the Campaign (the “Winner”) for each category will receive a prize toward CEDIA Expo 2023 as follows: booths 100-600 sq.ft will receive 100 net square feet free (Approximate Retail Value: \$3,400); booths 601-1,200 sq.ft will receive 200 net square feet

free (Approximate Retail Value: \$6,800); and booths 1,201+ sq.ft will receive 300 net square feet free (Approximate Retail Value: \$10,200).
